From the North

Via I-287

Take I-287 South to Exit 17—Route 202/206 South, Somerville/Princeton (note: This exit is accessible from both spurs of I-287). Take Route 202/206 South past the Bridgewater Commons Mall, get in the right lane and follow the signs to Route 22 East. Get on Route 22 East and travel for approximately 1 mile. Go past a Sunoco and a Gulf station. Shortly you will see a sign for Baker & Taylor Deliveries. Take one of the next two rights into the Baker & Taylor property and follow the sign for visitor parking. **Go in the main entrance (large stained glass windows and doors). The tour will begin in the lobby.**

Via Garden State Parkway or NJ Turnpike

Take either the Parkway South to Exit 142 or the Turnpike South to Exit 14, and get on I-78 West. Take I-78 West to Exit 29 and get on I-287 South. Follow as above.

From the South

Via I-287

Take I-287 North to Exit 14B—Route 22 West (**Note: This is a left lane exit**). Pass the Courier-News building on your right and continue for approximately 1 mile to N.Bridge Street/ Somerville Exit (Note: DO NOT take N. Bridge Street/Bridgewater Exit). Follow the signs for Route 22 East. Stay on Route 22 East and go past a Sunoco and a Gulf station. Shortly you will see a sign for Baker & Taylor Deliveries. Take one of the next two rights into the Baker & Taylor property and follow the sign for visitor parking. **Go in the main entrance (large stained glass windows and doors). The tour will begin in the lobby.**

Via Route 202

Take Route 202 North toward the Somerville Circle and stay left (to go over the “flyover”). Once over the “flyover” get in the right lane and exit on to Route 22 East. Stay on Route 22 and look for a Sunoco and a Gulf Station. Shortly you will see a sign for Baker & Taylor Deliveries. Take one of the next two rights into the Baker & Taylor property and follow the sign for visitor parking. **Go in the main entrance (large stained glass windows and doors). The tour will begin in the lobby.**

From the East

VIA I-78

Take I-78 West to Exit 29 and get on I-287 South. Take I-287 South to Exit 17—Route 202/206 South, Somerville/Princeton (note: This exit is accessible from both spurs of I-287). Take Route 202/206 South past the Bridgewater Commons Mall, get in the right lane and follow the signs to Route 22 East. Get on Route 22 East and travel for approximately 1 mile. Go past a Sunoco and a Gulf station. Shortly you will see a sign for Baker & Taylor Deliveries. Take one of the next two rights into the Baker & Taylor property and follow the sign for visitor parking. **Go in the main entrance (large stained glass windows and doors). Via Route 22

Take Route 22 West into Bridgewater. Pass the Courier-News building on your right and continue for approximately 1 mile to N.Bridge Street/ Somerville Exit (Note: DO NOT take N. Bridge Street/Bridgewater Exit). Follow the signs for Route 22 East. Stay on Route 22 East and go past a Sunoco and a Gulf station. Shortly you will see a sign for Baker & Taylor Deliveries. Take one of the next two rights into the Baker & Taylor property and follow the sign for visitor parking. **Go in the main entrance (large stained glass windows and doors). The tour will begin in the lobby.**

From the West

Via I-78

Take I-78 East to Exit 29 and get on I-287 South. Take I-287 South to Exit 17—Route 202/206 South, Somerville/Princeton (note: This exit is accessible from both spurs of I-287).
